

## GENERAL TERMS & CONDITIONS FOR EXHIBITORS

1. **BOOKING OF STALL** : The booking is done on “first come first served basis”, subject to receipt of payment as per Clause 6 below. Kindly book your space immediately and get the stall of your choice by paying 100% payment in advance. In case you desire to apply through requisite application, you may download the same or use the form enclosed along with the exhibition brochure.
2. **ALLOCATION OF SPACE** : The space to be allotted to the exhibitor shall be at the discretion of the All Kerala Photographers’ Association (AKPA). The AKPA reserves the right to alter the space, the area and the dimension of the space applied for, without Assigning any reason.
3. **DATES OF EXHIBITION** : **29, 30, JUNE, 1 JULY 2017**
4. **VENUE** : ADLUX INTERNATIONAL CONVENTION CENTRE, ANGAMALY, ERNAKULAM
5. **EXHIBITION TIMINGS** : 10.00 am to 6.00 pm  
Visitor’s entry to exhibition will only be allowed till 5.00 pm on the last day of the event.
6. **STALL TARIFF**  
Rs. 4,500/- Per Sq. Mtr. for Standard Stall and Rs. 5,000/- Per Sq. Mtr. for Premium Stall  
**Additional Electricity Charges:**
  - Connection Charges : Single (1)/ Three(3)Phase : Rs. 4,500/- (for 3 Days)
  - Consumption Charges : Rs. 450/- per KW /Day**Service tax extra 14.5% will be levied on the above rates.**  
**The Above Rates And Charges Are For Providing The Following Facilities With Conditions:**
  - A. Each stall constructed by extruded aluminum octonorm section with laminated plywood inserts height of 2.5 meters
  - B. Standard fascia (Stall Name) will be cut in self adhesive vinyl, and the same will be pasted in all stalls uniformly.
  - C. Three spotlights will be provided per 9sq. mtr. (unit) under shell scheme only. Number of units will be calculated in multiples of 9 sq. mtr. in order to provide light, table, chair, spotlight, power points etc.
  - D. One table and two chairs per unit stall will be supplied.
  - E. One 5 amp power socket in each unit stall.
  - F. Inside built up area will be carpeted as per AKPA specification.
7. **EXHIBITION HANDOVER SCHEDULE**
  - I. Shell Scheme : by 2.00 pm on 28 June 2017
  - II. Bare Space : by 12.00 noon on 27 June 2017
8. **INSURANCE** :  
All exhibitors are advised to insure their personnel, exhibits, etc. in their own interest.
9. **SALES OF GOODS** : **Sale of goods at the exhibition centre can be done by the exhibitors only if they have obtained prior Permission for such sale from the Sales Tax Department in Ernakulam and the liability for payment of sales tax is solely the responsibility of the exhibitor. AKPA does not have any responsibility if any Sales Tax Inspector visits the stall at the time of sale.**
10. In these Conditions the term “Exhibitor” means the signatory of this application and includes all employees or agent of such and “The Organizer” means All Kerala Photographers Association.
11. The Exhibitor is deemed to have obtained the consent of all the individual participants to all the conditions of this contract.
12. The stall cannot be confirmed until payment in full is received. Payment by the stipulated date is pre-requisite condition governing the use of the stall and participation in the Exhibition. In the event of default of payment by the stipulated date, the Organizer shall reserve the right to claim dues in full from the defaulting Exhibitor, who will not be entitled to any form of Compensation whatsoever. If the Exhibitor does not pay the balance of the contract price at the prescribed time, the Organizer Reserves the right after due notice to the Exhibitor or the agents appropriate to cancel the booking. In this event, or if the Exhibitor cancels the booking after the application is granted, the deposit will be forfeited.
13. Exhibitors may avail the services of the material handling agency authorized by the organizer. No other agency will be allowed to operate at the venue.
14. The Organizer shall have full power to determine in every respect the allocation of area and position of space and it shall be entitled for any reason which in its sole opinion is in the general interest of the Exhibition to vary the general layout or the situation and area of any particular stand even if already allocated and the Exhibitor shall accept a new allotment of space in substitution of that originally allotted.
15. The exhibitor shall ensure that the stall is vacated within five hours of the close of the exhibition on the last day. The organizer will not in any way be responsible or liable for the general security after the close of the exhibition on the last day. In the event the Exhibitor fails to vacate the premises within the time stipulated by the Organizers, any additional charges by way of rentals charged by the venue will be charged to the exhibitor and be payable by him.
16. Possession of space will be given only on receipt of full payment, including space rental and electricity charges etc. Possession will be given 18 hours before the opening of the exhibition. Display will have to be completed 4 hours before opening of the exhibition.
17. The Exhibitor shall occupy the space allotted on the day prior to the opening of the Exhibition. In the event of default due to any cause whatsoever the Exhibitor shall pay to the Organizer a further sum in liquidated damages equal to the total charge for for the space and the Organizer shall have the right to deal with space in any way it thinks best.
